The Traditional Approach to eDiscovery Is High-Cost And High-Risk

eDiscovery costs are out of control and traditional corporate processes are slow and risk-laden. According to the Sixth Annual Fulbright & Jaworski Litigation Trends survey, “one-third of in-house counsel at companies with more than \$1 billion in annual revenue reported that 20 percent or more of their yearly litigation spend was eaten up by preproduction privilege reviews.” Some organizations report spending up to \$5 million simply for privilege reviews because they are unable to reduce the amount of potentially responsive information.

Traditionally, organizations take a reactive, disjointed approach to eDiscovery. Legal teams can’t efficiently manage the eDiscovery process while IT teams lack the enterprise-grade infrastructure and applications to execute discovery. This has negative repercussions:

- Higher costs due to expensive over-collection and preservation
- Large burden on IT from the the manual process of collecting hundreds of gigabytes of unstructured data that happens to be scattered across diverse systems and locations and exists in a variety of digital formats
- Higher risk of sanctions from inability to collect or for spoliation given the large amount of data moving between multiple applications.

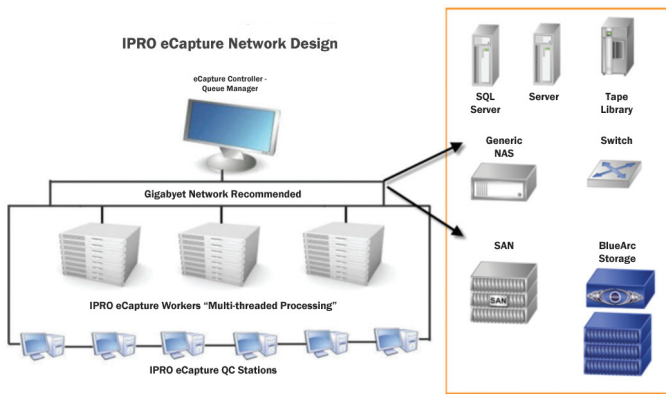


Bring Efficiency To eDiscovery With IPRO and BlueArc
